Vitamin A, riboflavin, folic acid, vitamin B6, vitamin B12, choline, iron, calcium, phosphorus, and potassium are among the other vitamins and minerals it contains. This is in line with Angriani's (2024) explanation that the livestock business most commonly cultivated by farmers is layer and broiler chickens because they are easy to raise, have a relatively short growth period, and the business has good prospects considering the high market demand, as well as their high nutritional value and affordable price. The system of layer chicken farming has been implemented for a long time, because fundamentally, life is supported by reciprocal relationships among humans. In this case, how humans engage in mutualistic symbiosis with pets. Keeping chickens is one form of applying prophetic values, as raising chickens will provide many benefits for humans. - 3) Freedom from pain, injuries, and diseases: prevention, diagnostics, and treatment.
- 4) Freedom to express normal behavior: sufficient space, adequate equipment, and contact with pen mates.
- 5) Freedom from fear and suffering: husbandry conditions and treatment that does not cause psychic suffering. This is consistent with the statement by United Nations Environment Programme (2019) that technology and science are developing quickly and offer fresh chances to improve poultry production and our knowledge of poultry, which may lead to a more moral society than we have in the past. One dimension of sustainable food systems is farm animal welfare. Animal welfare is increasingly understood as a morally important dimension of sustainable agriculture and is coming under increasing demand by governments, retailers, consumers, and voters.
